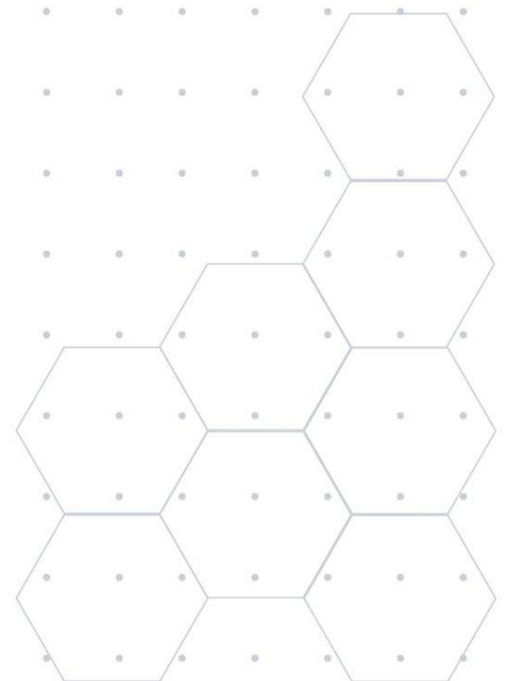
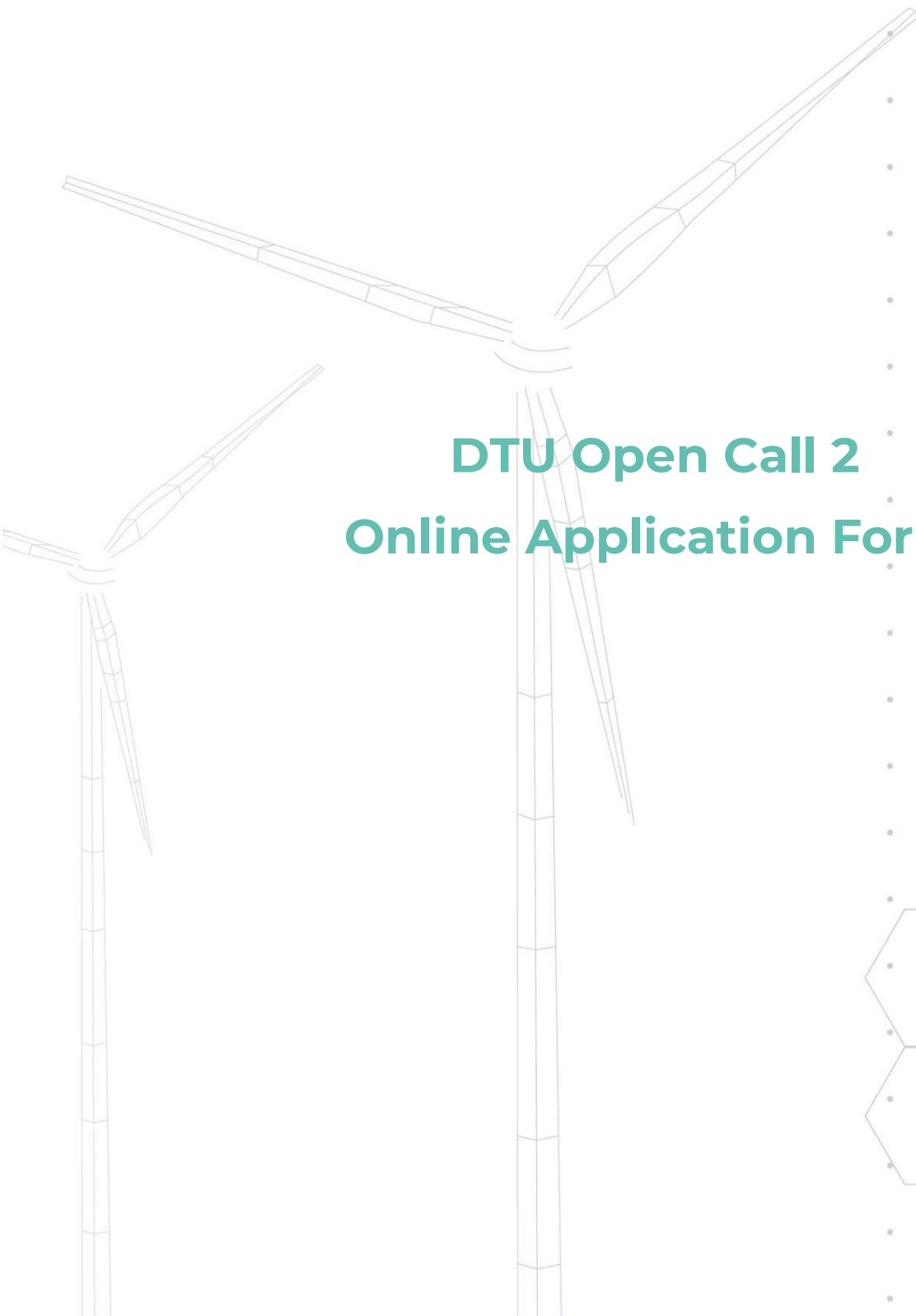

Academic/Professional Background: The program is aimed at individuals holding a Bachelor of Science in Engineering (B.Sc. Eng), Bachelor of Engineering (B.Eng.) or a Bachelor of Natural Science (B.Sc.) degree obtained at an internationally recognized university/higher education institution*. DTU does not admit students with an interdisciplinary bachelor's degree. DTU does not accept applicants with a minor in Engineering or in Natural Science.

Nationality: Applicants must be a passport holder of Bosnia and Herzegovina, Kosovo, Moldova, Montenegro, North Macedonia, Serbia, Türkiye, Ukraine, or Albania.

English Language Competency: All applicants must demonstrate English language proficiency with an official score report from one of the following tests:

- IELTS Academic (computer-based, paper-based, or online): Minimum overall score of 6.5
- TOEFL iBT (including the Internet-based test, Special Home Edition, or Paper Edition*): Minimum score of 88
- Cambridge English – C1 Advanced (CAE) or C2 Proficiency (CPE): Minimum overall score of 180

Note: Documentation for the English language competency is not required for native English speakers.

Application Submission: All applicants must have an acknowledged, submitted application to a DTU Master's program.

Note: Depending on your academic background, you may need to take up to 30 ECTS in supplementary courses in subjects such as mathematics, programming, physics, and statistics.
